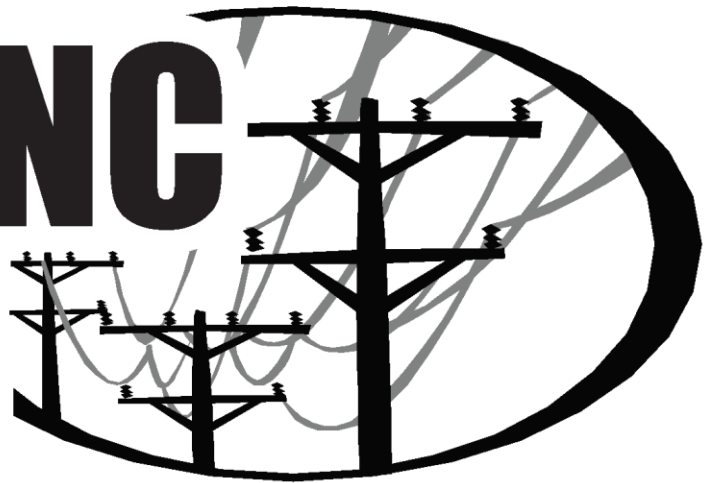

I hope this newsletter finds everyone well and that you are enjoying the summer.

Our Spring Luncheon was held at The Club on May 9, 2023, and was well attended. Our keynote speaker, Paula Marino, provided a summary of some of the new business areas being developed by the Southern Company and fielded questions on a broad range of topics.

Our next get-together will be at the APC auditorium downtown on Monday, July 10 (parking instructions and map on Page 10 of this newsletter). Sloss Furnaces were built during the development boom that followed the Civil War as entrepreneurs sought to exploit the natural resources of Jones Valley, including iron ore. The city of Birmingham was founded during this time, in 1871. Ten years later Colonel James Withers Sloss ordered that construction begin on the furnaces. We will offer a tour of the facility at which time our guide will provide a detailed history. Specific plans are still being worked out, but we plan to have food trucks and we will provide another keynote speaker.

VOGTLE 3-4 UPDATE:

Georgia Power announced on May 29, 2023, that Vogtle Unit 3 has safely reached 100 percent power, marking a major milestone towards commercial operation and service for customers. This milestone marks the maximum energy the unit is licensed to produce in the reactor core and is the first time the unit has reached its expected output of approximately 1,100 electric MW, which can power an estimated 500,000 homes and businesses.

“Unit 3 is currently undergoing testing through the full range of plant operations, including safely running at various power levels and operating through real-life conditions just as it will over the next 60 to 80 years after the unit enters commercial operation,” said Kim Greene, chairman, president, and CEO of Georgia Power. “As we enter the final stages of startup testing, reaching 100 percent power for the first time is an exciting milestone. It tells us we’re close to finishing the unit safely and bringing it online to power Georgia homes and businesses with reliable, emissions-free energy for decades to come.”

In alignment with the testing performed throughout power ascension, testing at the 100 percent power level is focused on the operation of the reactor, plant control systems for the reactor and support systems, and integrated plant operations. Plant performance is monitored at various conditions and data is gathered and evaluated by site engineers. With the unit reaching full power for the first time, other tests must be performed at this power level before the unit is available for reliable dispatch in accordance with its combined operating license.

Once all startup testing is successfully completed and the unit is available for reliable dispatch, Vogtle Unit 3 will enter commercial operation.

Gadsden Selected As Home of New Microreactor Manufacturing Plant

Ultra Safe Nuclear Corporation (USNC) will construct a Micro-Modular Reactor assembly plant in Gadsden, USNC's Chief Nuclear Officer Dan Stout announced alongside Gadsden Mayor Craig Ford on Wednesday at the 10th Advanced Reactors Summit and Technology Trailblazers Showcase in Charlotte, North Carolina.

The 57,800 square foot facility will manufacture the modules used to construct USNC's microreactors. The facility will not deal with radiological elements; no nuclear fuel or other radioactive material will be used or stored at the plant.

Following a search that considered sixteen states and hundreds of potential sites, USNC selected Gadsden as the location for the new plant and entered a project agreement with Governor Kay Ivey.

"Alabama is home to an impressive array of highly innovative companies, so our state is an ideal place for Ultra Safe Nuclear Corporation's new advanced microreactor assembly plant," Ivey said. "This unique facility will benefit the Gadsden community through a significant investment and the creation of good jobs while also reinforcing Alabama's reputation for cutting-edge manufacturing operations."

The plant is scheduled to begin construction in 2024 and become operational in 2027.

She holds a bachelor's degree in commerce and business administration from the University of Alabama and a Juris Doctor from the University of Alabama School of Law. She also is a graduate of the MBA program at Samford University.

Leigh is a native of Birmingham and serves on numerous boards of directors, including UAB O'Neal Comprehensive Cancer Center, Public Affairs Research Council of Alabama, and Ascension Alabama Health System. She chairs Samford University's Board of Overseers and is past president of the Kiwanis Club of Birmingham. Davis also serves on Synovus Bank's Birmingham Advisory Board, the University of Alabama School of Law Board of Governors, and the University of Alabama Culverhouse College of Business Board of Visitors.

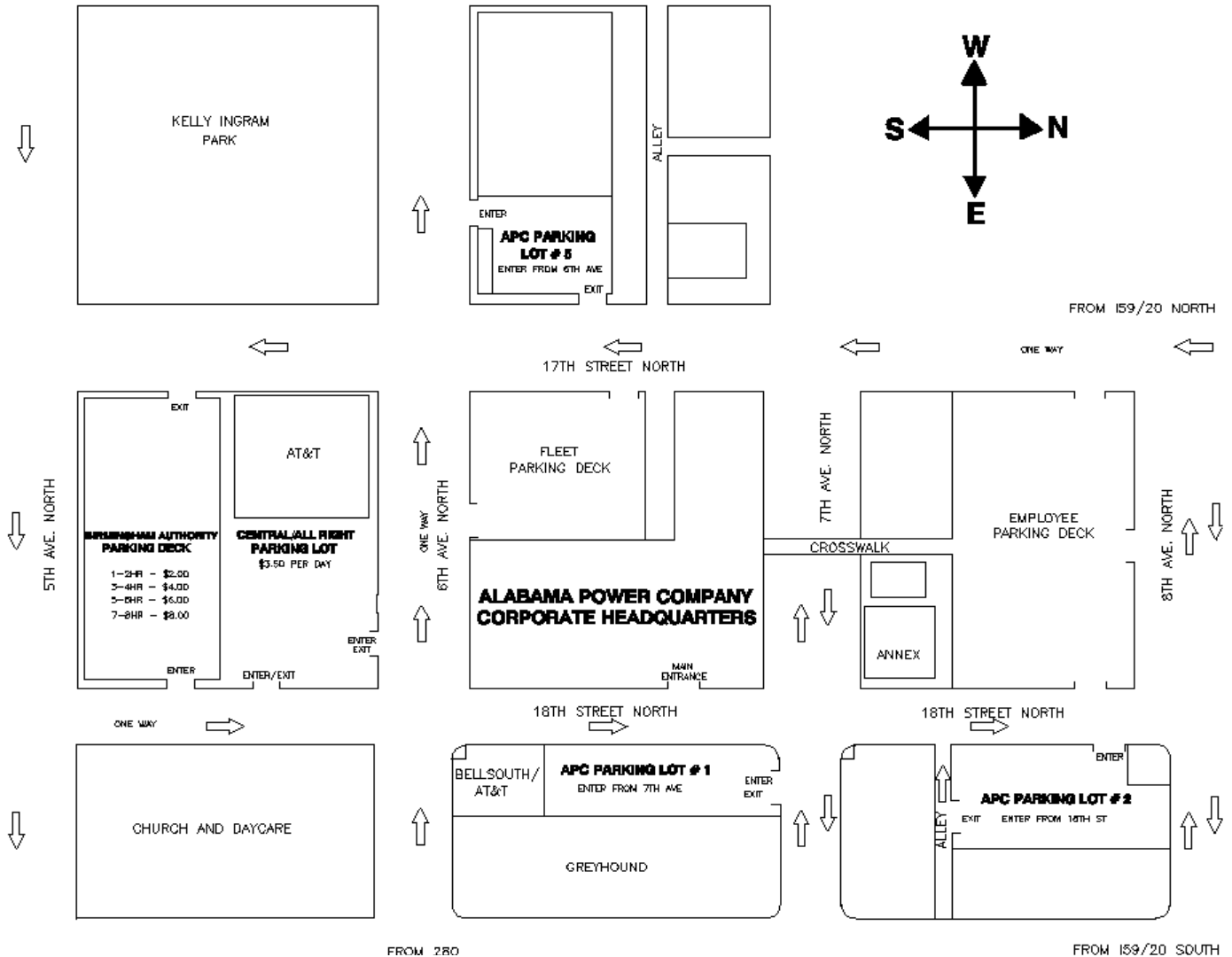

HOLIDAYS TO REMEMBER IN JULY



The Story of the Fourth of July

The Declaration of Independence:

We celebrate American Independence Day on the Fourth of July every year. We think of July 4, 1776, as a day that represents the **Declaration of Independence** and the birth of the United States of America as an independent nation. But July 4, 1776, wasn't the day that the Continental Congress decided to declare independence (they did that on July 2, 1776). It wasn't the day we started the American Revolution either (that had happened back in April 1775). And it wasn't the day Thomas Jefferson wrote the first draft of the Declaration of Independence (that was in June 1776). Or the date on which the Declaration was delivered to Great Britain (that didn't happen until November 1776). Or the date it was signed (that was August 2, 1776).

So, what did happen on July 4, 1776?

The Continental Congress approved the final wording of the Declaration of Independence on July 4, 1776. They'd been working on it for a couple of days after the draft was submitted on July 2nd and finally agreed on all the edits and changes. July 4, 1776, became the date that was included on the Declaration of Independence, and the fancy handwritten copy that was signed in August (the copy now displayed at the National Archives in Washington, D.C.) It's also the date that was printed on the Dunlap Broadside, the original printed copies of the Declaration that were circulated throughout the new nation. So, when people thought of the Declaration of Independence, July 4, 1776, was the date they remembered.

In contrast, we celebrate Constitution Day on September 17th of each year, the anniversary of the date the Constitution was signed, not the anniversary of the date it was approved. If we'd followed this same approach for the Declaration of Independence, we'd be celebrating Independence Day on August 2nd of each year, the day the Declaration of Independence was signed!

How did the Fourth of July become a national holiday?

For the first 15 or 20 years after the Declaration was written, people didn't celebrate it much on any date. It was too new and too much else was happening in the young nation. By the 1790s, a time of bitter partisan conflicts, the Declaration had become controversial. One party, the Democratic-Republicans, admired Jefferson, and the Declaration. But the other party, the Federalists, thought the Declaration was too French and too anti-British, which went against their current policies. By 1817, John Adams complained in a letter that America seemed uninterested in its past. But that would soon change.

After the War of 1812, the Federalist party began to come apart and the new parties of the 1820s and 1830s all considered themselves inheritors of Jefferson and the Democratic-Republicans. Printed copies of the Declaration began to circulate again, all with the date July 4, 1776, listed at the top. The deaths of Thomas Jefferson and John Adams on July 4, 1826, may even have helped to promote the idea of July 4 as an important date to be celebrated. Celebrations of the Fourth of July became more common as the years went on and in 1870, almost a hundred years after the Declaration was written, Congress first declared July 4 to be a national holiday as part of a bill to officially recognize several holidays, including Christmas. Further legislation about national holidays, including July 4, was passed in 1939 and 1941.

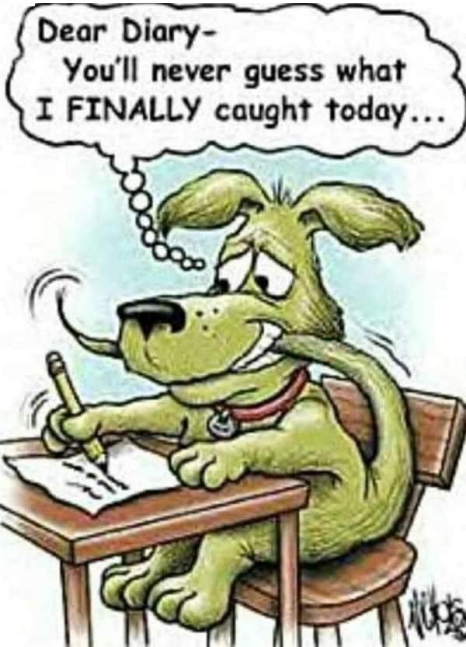


Bet you didn't know... Here Are Some Interesting Facts about Bees

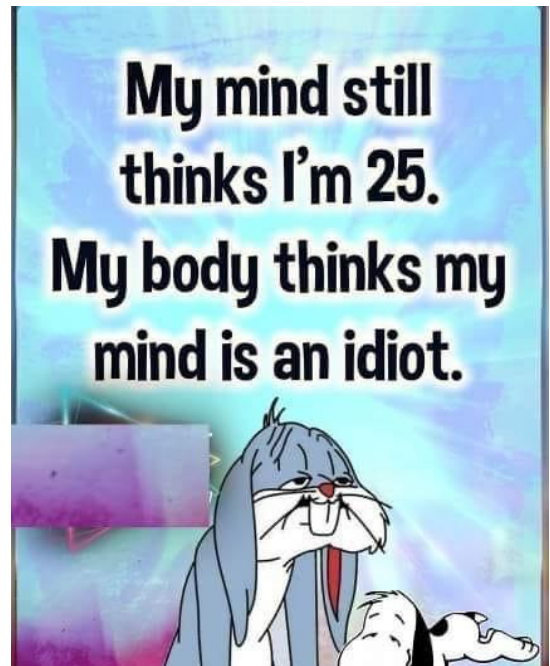
Did you know that...

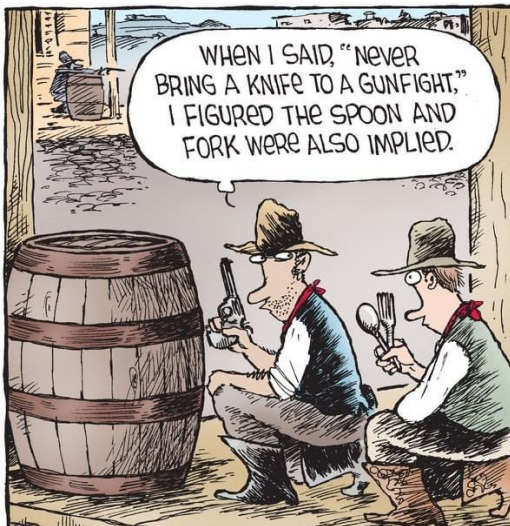

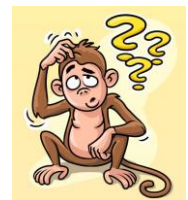
